NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. HOW TO ENTER

- a. The 98.5 WNCX Classic Café Contest (the “Contest”) will begin on 12:00am Eastern Time (“ET”) on January 1, 2009 and end at 11:59pm ET on December 31, 2009 (the “Contest Period”).
- b. To participate in the Contest, you may enter via the following method(s):
Log on to www.wncx.com and click on the “Classic Cafe” graphic/link to register for the Contest. Complete the online registration form including: first name and last name, complete address, city, state, zip code, home telephone number, date of birth, a valid email address, and the names of three (3) of your current co-workers’ names.

All online entries must be received by noon each Friday to be eligible for the next weeks daily prize drawing. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an Internet access provider, online serve provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address. WNCX is not responsible for entries not received due to difficulty accessing the Internet, service outage or delays, computer difficulties or other technological glitches. For purposes of these Official Rules, “receipt” of an online entry will be solely determined when the www.wncx.com web server records the entry information. Any automated computer receipt (such as one confirming delivery of email) does not constitute actual receipt of an entry for purposes of these Official Rules. WNCX’s computer is the official time keeping device for this Contest. Use of any device to automate entry is prohibited.

- c. Only one (1) Internet entry per person and one (1) Internet entry per email address is permitted.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all WNCX listeners who are 18 years of age or older and who legally reside in any of the following Cleveland, Ohio Metropolitan area counties: Erie, Huron, Richland, Ashland, Lorain, Medina, Wayne, Holmes, Tuscarawas, Carroll, Stark Summit, Portage, Geauga, Lake, Ashtabula, Trumbull, Mahoning and Columbiana. Employees of WNCX, its licensee, corporate parent, affiliated entities, its affiliated advertising agencies, participating sponsors/promotional partners, other radio stations in the Cleveland metropolitan

area and the members of their immediate families are ineligible to participate or win.

- b. Listeners are eligible to win a WNCX Contest only once every thirty (30) days and a prize valued at \$600.00 or more only once every six months. Only one winner per household is permitted in any Contest.
- c. Winner will be required to present valid government issued photo identification and must sign all required Contest releases in order to claim prize.
- d. Contestants are required to provide truthful information and WNCX will reject and delete any entry that it discovers to be false or fraudulent. WNCX will also disqualify and delete any entry received from persons under the age of 13 in compliance with the Children’s Online Privacy Protection Act.

3. PRIZES

- a. One (1) prize awarded each weekday during Contest Period. The prize will consist of a voucher for lunch for four (4) at that weeks designated local area restaurant. Some restrictions may apply. Tax/tip not included. Prize cannot be used towards the purchase of alcoholic beverages. (Approximate Retail Value within the range of \$20 - \$50.)
- b. All prizes or prize certificates will be mailed to the winner. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of WNCX management with respect to the Contest are final.
- b. For the duration of the Contest Period, one (1) daily winner will be selected via random drawing weekdays during the 12:00 pm EST hour, from all eligible entries received by the entry deadline.
- c. The odds of being selected the Daily Winner is dependent on the number of eligible entries received prior to the weekly deadline.
- d. WINNER must listen but not BE PRESENT TO WIN.

- e. Winner will be notified of winning on the air daily between approximately 12:00 pm and 1:00 pm ET. Winner may be required to execute and return any required affidavit of eligibility and/or liability/publicity release prior to receiving the prize. In the event the winner does receive their prize, or the prize is returned due to incorrect mailing address or information, the prize will be forfeited.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. Winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by the Station in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize.
- b. By participating in the Contest, the winner or winners agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this Contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, WNCX in its sole discretion may require Contest winners (and their travel companions, if any) to sign a liability release, agreeing to hold WNCX, its corporate licensee, its parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the Contest.
- d. WNCX, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the WNCX Web Site or is otherwise in violation of the rules. It further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
- e. WNCX reserves the right to make changes in the rules of the Contest, including the substitution of a prize or equivalent value, which will become effective upon announcement.
- f. Failure to comply with the Contest rules may result in a Contestant's disqualification solely at the discretion of WNCX.
- g. WNCX is not responsible for typographical or other errors in the printing, the offering or the administration of the Contest, or in the announcement of a prize.
